

Foodland Supermarkets Cast Iron Cookware Campaign – Terms & Conditions

Promotion Commences: Wednesday 24 September 2025

Promotion Ends: Tuesday 26 May 2026

1. GENERAL

- 1.1. The Foodland Supermarkets Cast Iron Cookware campaign (“**Campaign**”) is managed and promoted by Impeach Pty Ltd ACN 008 143 959 as trustee for the Foodland Promotions Unit Trust, ABN 85 528 062 001 of 191 Flinders Street, Adelaide South Australia, 5000, referred to herein as Foodland (“**Promoter**”).
- 1.2. Participation in this Campaign is governed by these Terms and Conditions. Any person not complying with these terms and conditions is ineligible to participate in the Campaign. Acceptance of a Foodland digital stamp (“**Stamp**”) and participation in this Campaign is deemed acceptance of these Terms and Conditions.
- 1.3. Participating Foodland Supermarkets are listed in Schedule A (“**Participating Foodland Supermarkets**”).

2. FOODLAND SUPERMARKETS CAST IRON COOKWARE STAMP PARTICIPATION

- 2.1. For every \$25 spent in one transaction after any applicable discounts and exclusions set out below (“**Qualifying Spend**”) at any Foodland Supermarket store between 12.01 am (ACST) on Wednesday 24 September 2025 and 11.59 pm Tuesday 26 May 2026 (“**Campaign Period**”), Foodland will provide customers with one Stamp, provided the customer is a Foodland Great Rewards App member and has scanned their Foodland Great Rewards App in store at the time of purchase. Excludes tobacco, gift cards and commission related sales such as phone re-charge, dry cleaning, charity products, and continuity sales as outlined in clause 2.6. The offer is available while stocks last.
- 2.2. Customers will be able to earn stamps until Tuesday 26 May 2026 and must redeem cookware by Tuesday 2 June 2026.
- 2.3. Subject to clauses 2.10 and 2.11, one Stamp will be given per each Qualifying Spend. For example, \$25 = 1 Stamp, \$50 = 2 Stamps, \$75 = 3 Stamps and so on.
- 2.4. The Stamp is a digital voucher that is allocated to the customer’s Foodland Great Rewards App on a Qualifying Spend and can be accumulated over the Campaign Period to redeem for Foodland Cast Iron Cookware (“**Products**”), provided the customer has accumulated enough Stamps to redeem the Foodland Cast Iron Cookware set out in the product listing in the clause 3.2 below.
- 2.5. The total number of Stamps a customer has earned in a transaction, and in total from all Qualifying Spends during the Campaign Period, can be found on their Foodland Great Rewards App. The total number of Stamps earned and redeemed to date can also be found in the Foodland Great Rewards member section on the mobile application.
- 2.6. This Campaign is only available to current Foodland Great Rewards members or new Foodland Great Rewards members who join during the Campaign Period. Stamps are automatically applied to the Foodland Great Rewards account once the Qualifying Spend amount has been reached. Standard Foodland Great Rewards Terms and Conditions apply and are available at www.foodlandsa.com.au.
- 2.7. The Qualifying Spend is calculated after applying all savings and discounts and excludes tobacco, gift cards and commission related sales such as phone re-charge, dry cleaning, charity products, and continuity sales. Other products may also be excluded at Foodland’s discretion, acting reasonably, during the Campaign Period.
- 2.8. Stamps will only be available to be earned during the Campaign Period or until such time as there is no stock remaining of the Foodland Cast Iron Cookware (whichever is earlier). Foodland accepts no liability if Foodland Cast Iron Cookware becomes unavailable, for whatever reason, except to the extent caused by the negligence, fraud or wrongful act or omission of Foodland.
- 2.9. Foodland, at their absolute discretion, reserves the right to make the Campaign and the ability to earn Stamps available to any person (or persons) prior to the Campaign Period commencing.
- 2.10. In addition to clause 2.7 above, Foodland may, acting reasonably, decide at its absolute discretion to extend or otherwise amend the Campaign Period.

2.11. Foodland may from time to time at its discretion offer bonus stamps (“Bonus Stamps”). One Bonus Stamp will be awarded when a customer spends \$25 in one transaction, scans their Foodland Great Rewards App, and also purchases one or more products from a participating brand or product range. A maximum limit of one Bonus Stamp per participating brand or product range, per transaction applies. A full list of participating products can be found in clause 9.1 of this document. Foodland will communicate in store and/or externally if, how and when Bonus Stamps will be provided.

3. REDEEMING CAST IRON COOKWARE CREDITS

3.1. Foodland customers may redeem Stamps for Foodland Cast Iron Cookware products at any Foodland Supermarket store from Wednesday 24 September 2025 to Tuesday 2 June 2026 (“**Redemption Period**”), provided they have enough Stamps in their account to redeem as per the product listing in clause 3.2, and while stocks last.

3.2. The following Foodland Cast Iron Cookware products are available to be redeemed during the Redemption Period with Stamps or purchased at retail price at any Foodland Supermarket, while stocks last.

3.3. Only the Foodland Cast Iron Cookware products listed in clause 3.2 are eligible to be redeemed for Stamps, to the exclusion of all other cookware products sold at Foodland.

3.4. Rainchecks will not be provided during the Campaign Period or Redemption Period.

3.5. Stamps can only be redeemed for Foodland Cast Iron Cookware while stocks last and during the promotion.

3.6. Stamps will expire at the end of the Foodland Cast Iron Cookware Promotion. For the avoidance of doubt, Stamps earned during this promotion may not be used towards other Great Rewards or Foodland promotion.

3.7. Products will only be redeemable in a Foodland Supermarket store.

3.8. Products can be purchased during the Campaign Period at the retail price \$89.00 as indicated in store at the customer’s choice if the customer does not have sufficient Foodland Great Rewards Stamps to redeem Products, or if the customer is not a Foodland Great Rewards member.

3.9. To redeem any Stamps in store, customers must visit a Foodland Supermarket store and select the products they wish to redeem/purchase from the merchandise stand displayed. Customers are then required to take their Products through a checkout where they can scan the Products along with their Foodland Great Rewards App. If enough Stamps have been accumulated, the customer will be given the option to redeem the Products for Stamps. If there is not enough Stamps, the customer will be given the option to purchase the Product at the retail price displayed. Once redeemed, the customers Stamps count will revert to zero.

4. REDEMPTION PROCESS

- Users will browse all products they can redeem stamps on the app
- Users will be prompted to make sure they are in the store before redeeming as there is a time limit on the redemption (60 minutes)
- Users will select their preferred product at the store and take it to the register

- Users will then redeem via the app and be shown a barcode and a countdown timer
- At the register, the product will be scanned, then the barcode on the app will be scanned to apply a 100% discount to the redeemed cookware.
- The stamps used will then be removed from the app and the customer will continue to earn stamps for future purchases during the promotion.
- Users will have until Tuesday 2 June 2026 to redeem any stamps for Cookware.

5. LIABILITY

- 5.1. Certain legislation may imply warranties or conditions or impose other obligations including consumer guarantees which cannot be excluded, restricted, or modified. To the extent permitted by law, Foodland excludes all guarantees, warranties, conditions, or terms that apply under or are implied by statute, common law or trade custom or usage except as set out in these terms and conditions.
- 5.2. If in the conduct of this Campaign, Foodland is liable for a breach of any guarantee, warranty, condition, or other term that applies under the Competition and Consumer Act 2010 (Cth.) or is implied by any other Commonwealth, State or Territory law that cannot be excluded, Foodland's liability under that legislation is limited, to the extent permitted by law, to the cost of replacement of any benefit provided.
- 5.3. Foodland, its associated agencies, companies and third parties associated with this Campaign will not be liable for any loss (including, without limitation, indirect, special or consequential loss, loss of opportunity, or loss of profits), expense, damage, personal injury, illness or death which is suffered or sustained (whether or not arising from any person's negligence) in connection with this Campaign or accepting or using any benefit, except for any liability which cannot be excluded by law (in which case the liability is limited to the minimum allowable by law), and except to the extent that such liability arises as a result of Foodland's fraud, negligence or wrongful act or omission. Nothing in these conditions restricts, excludes, or modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the Competition and Consumer Act 2010 (Cth).
- 5.4. As a condition of accepting the Stamps participating in the Campaign on behalf of a recipient or customer under the age of 18 years old, the recipient's or customer's parent or guardian accepts these terms and conditions.

6. INTELLECTUAL PROPERTY RIGHTS AND WEBSITES

- 6.1. The material contained on the site www.foodlandsa.com.au and www.foodlandsa.com.au/foodland-cast-iron-cookware-campaign ("**Campaign Websites**") and Products, technology and processes contained on them by be the subject of intellectual property owned by Foodland or by third parties. No licence is granted in respect of those intellectual property rights other than as set out in these terms.
- 6.2. Trademarks (whether registered or unregistered) and logos on the Campaign Website must not be used or modified in any way without obtaining the prior written consent of Foodland.

7. PRIVACY NOTICE

- 7.1. Foodland treats compliance with the Australian Privacy Act 1988 ("Act") and the Australian Privacy Principles very seriously and is committed to handling the personal information we collect in accordance with our Privacy Policy and the requirements of the Act.
- 7.2. To the extent that Foodland is collecting or accessing personal information as part of this Campaign, Foodland may use such information including personal information that a member of a registered Foodland Great Rewards ("Member") has provided to it for the purpose of running the Campaign, and in advertisements, publications, media statements and other Campaign material associated with this Campaign.

(including but not limited to TV, radio, catalogue, and digital catalogue, press and point of sale) without compensation for the purposes of publishing and marketing the Campaign.

9. GENERAL

- 9.1. These terms and conditions are governed by the laws of South Australia in Australia, and any dispute in relation to these terms and conditions or your access or use of the Campaign Websites will be the exclusive jurisdiction of the courts of South Australia.
- 9.2. Where it is in Foodland's legitimate interests to do so, Foodland may, acting reasonably, vary these terms and conditions at any time, and by accepting a Stamp you consent to any variations. Foodland will notify in writing of any material variations unless any variation has a neutral or positive effect on you.
- 9.3. Any failure by Foodland to act or enforce these terms and conditions immediately will not be considered a waiver of Foodland's right to take any such action.
- 9.4. If any of these terms and conditions are unenforceable or held to be invalid, the offending provision/s will be removed from these terms and conditions and the amended terms and conditions will remain in effect.
- 9.5. Each provision of these terms and conditions is severable. These terms and conditions remain enforceable even if individual clauses are removed or deemed unenforceable.
